Governor McMaster names Dr. Edward Simmer as first Director of the Department of Public Health

Columbia – Governor Henry McMaster recently announced his appointment of Dr. Edward Simmer as the first director of the South Carolina Department of Public Health (DPH). Dr. Simmer served as the director of the South Carolina Department of Health and Environmental Control (DHEC) from February 2021 until the agency's statutory reorganization in July 2024. The new law directed that the DHEC director serve as the interim director of the new agency until such a time as the governor nominates and the Senate confirms a permanent DPH director in 2025.




