Shuttle and valet service launched to support downtown Spartanburg businesses

OneSpartanburg, Inc., the City of Spartanburg and The Valet, LLC have launched valet and shuttle services to further support Downtown Spartanburg businesses.

After completing a pilot of the free valet service in December, it is now available from 4:30 - 10:30 p.m. Thursday through Saturday. Cars can be dropped off and picked up by The Peddler on Main St.

The shuttle service allows users to be picked up or dropped off in the stretch from Main Street Pub to Spill The Beans along Main St., spanning out to Magnolia Street and City Hall parking lots. The app-based shuttle service is available from 11 a.m. -4 p.m. Monday through Saturday.

"These services were the result of feedback from our downtown business community," said Katherine O'Neill, OneSpartanburg, Inc. Chief Economic Development Officer. "We believe this collaborative effort will benefit all downtown businesses by increasing access to storefronts."

The Valet, LLC, owned by Landon Cohen, will handle the shuttle and valet services, and related staffing.

"These parking and transportation options will help visitors and residents easily travel throughout downtown without having to worry about parking. As a result, we hope that this will encourage people to spend more time downtown when they visit, and explore what the downtown shops and businesses have to offer," said Terence Dawkins with The Valet.

The shuttle service can be used by downloading the My Trax GPS app. Users will need to enter the code "downtown" after choosing "view live tracking map." The app uses drivers' location to send a street-legal golf cart for pick-ups and drop-offs.

"As our downtown business community and our residents continue to navigate the pandemic, creativity and collaboration are Spartanburg's strengths. Born from that collaboration, this complimentary downtown valet parking and the new shuttle service will be hugely beneficial in supporting our local retailers and restauranteurs," said Spartanburg City Manager Chris Story.

SC State Fair accepting applications for Ride of Your Life Scholarship

Columbia – The South Carolina State Fair is accepting applications for its Ride of Your Life Scholarship program.

Fifty \$6,000 scholarships will be awarded to high school seniors across the state and will be paid out at \$1,500 a year over four years. Students pursuing two-year degrees will receive \$1,500 per year over the two-year period.

The scholarship funds must be used at a South Carolina university, college, or institution and may cover tuition or other educational expenses such as on-campus housing, a computer, or textbooks.

Scholarships are awarded based on academic and extracurricular achievement, communication skills, need and completeness of the application.

Scholarship applications must be completed online at scstatefair.org by March 15. The State Fair Scholars will be notified in mid - May.

Chapman Cultural Center and Hub City Writers Project launch the Southern Studies Fellowship in Arts and Letters

Chapman Cultural Center and the Hub City Writers Project have jointly received a \$150,000 grant from the Watson-Brown Foundation for a new, three-year initiative, the Southern Studies Fellowship in Arts and Letters.

This first-of-its-kind program will bring one earlycareer artist and one early career-writer to Spartanburg, South Carolina, for a ninemonth residency of research, creativity, teaching, and travel, culminating in a collaborative project informed by the region. The program, which will begin accepting applications this month, will be marketed nationally to artists and writers who are interested in immersing themselves in the culture of the American South. Creatives interested in the program can learn more and apply at www.southernstudiesfellowship.org.

"By bringing dynamic creative people together with dynamic arts organizations and scholars through the region, we will set in motion new explorations of the modern South that will reverberate beyond our community," said Jennifer Evins, Chapman Cultural Center President and CEO.

"This grant is designed to create a life-changing experience for the fellows, to provide engaging intellectual opportunities for local students and citizens, and to create a model program for community cultural study through art and literature," said Anne Waters, executive director of the Hub City Writers Project.

Over the three-year period of the grant, each Southern Studies Fellow will be provided with a furnished apartment with paid utilities in downtown Spartanburg and a monthly stipend. Applications for the program will be available online in early 2021, and the first fellows will come to Spartanburg from September 2021 to May 2022. It is open to residents of the United States.

The initiative replaces existing residency programs by Chapman and Hub

In addition to focusing on their own creative projects, the Southern Studies Fellows will have opportunities and requirements for educational community service in Spartanburg County; these will include regular college and high school classroom visits/lectures, readings, open studios, workshops, and projects affiliated with the host organizations. The fellows will be expected to contribute up to 20 hours per week in the following areas: community service, artist-writer collaboration, and out-of-town travel for project research.

A key component of this unique fellowship is the opportunity to interact with leading scholars, artists, and writers throughout the South. Each fellow will have opportunities to travel in the Southern region to conduct research at cultural and educational institutions, which will inform their work and will be critical in the development of their ideas for a collaborative project that expands the understanding of the modern South.

Named for Thomas E. Watson and J.J. Brown, the Watson Brown Foundation invests in education and historical preservation, annually awarding more than \$2.4 million in merit and need-based college scholarships to students from an eighteen-county region of Georgia and South Carolina. The foundation, based in Thomson, GA, also operates a grant program that encourages responsible scholarship on the South and supports historic preservation. Additionally, it owns and operates three historic sites in Georgia.

With roots that stretch back more than 50 years, the Chapman Cultural Center's mission is to provide cultural leadership for Greater Spartanburg by developing, strengthening, and promoting the scope, excellence and educational role of the arts, humanities and sciences, and to further their significance in the life of our community.

The Hub City Writers Project, founded in 1995, serves its mission to cultivate readers and nurture writers through its independent press, community bookshop, and diverse literary programming. ing chocolate for those health benefits alone, but the research is something chocolate lovers will watch.

So how much dark chocolate or unsweetened cocoa powder is the potential ticket to good health? None of the studies to date have determined the optimal daily serving. Many health experts are comfortable recommending daily dark chocolate in small amounts -- an ounce or two daily -- if it's a food you already enjoy and can afford it in your calorie budget.

Making chocolate milk with unsweetened cocoa powder (containing 82%) cocoa) stirred into skim milk and sweetened with stevia -as opposed to the highly processed and sugar-sweetened version typically found on supermarket shelves -- is a healthy choice. In one study, chocolate-milk drinkers who used the healthy drink recipe showed marked improvement in heart health, including a boost to the "good" HDL cholesterol.

Not all chocolate is created equal: The higher the cocoa content, the greater the health benefits from flavonoids, which help protect against aging and some chronic diseases. Following unsweetened cocoa powder on the list for highest percentage of cocoa is unsweetened baking chocolate and dark chocolate.

A final word of caution: check the ingredients label to see where sugar is listed. The further down the list the better, because that indicates a smaller amount of sugar. Weigh the extra calories in chocolate before you spend them -- and then enjoy every morsel!



Turn Old Crayons Into Valentine Art

If broken and worn-down crayons are showing up in drawers, backpacks, art-supply tubs and even the car, don't throw them out! Instead, collect them all in a box and recycle them into fun Valentine art for the heart.



You and your school-age kids can mold some clever designs when you melt down the old and create new, attractive and useful heart-shaped crayons — perfect for tucking into classroom valentine envelopes for something extra, or for eye-catching toppers on wrapped-up valentine gifts. Here's how: 1. Remove the paper wrapper from crayons in your favorite Valentine's Day colors such as shades of red and pink. Let the kids break the crayons into pieces and put them into piles according to the colors.

2. Put the pieces, according to color, in small, heat resistant glass jars, such as empty baby-food jars.

3. With adult help, fit a small rack inside a saucepan, and place the jars on the rack. Fill the saucepan with enough water to cover 1/2 inch of the jars. Heat the water until the crayons melt. Keep an eye on them at all times. 4. An adult should carefully pour the melted wax into a plastic candy mold tray (available at craft and kitch-en-supply stores in a variety of heart shapes. You might even find X's and O's). Or, use ice-cube trays that come in heart shapes.

The wax will harden quickly and pop out of the mold easily. You could put the tray in the freezer, or outdoors if you live in a cold climate, for a few minutes to speed up the process.

For added effect, pour a contrasting color into the mold after the first layer of wax has hardened. This will produce a two-tone crayon.

Now, try out a new crayon heart on a piece of paper and discover that it really works.



VA, Fitbit Team Up

The VA and Fitbit have hooked up to provide one year of free membership to eligible veterans who have the device. This couldn't have come at a better time, when we need more exercise, less stress and better sleep at night.

stress and better sleep at night. Up to 10,000 veterans (including caregivers and VA staff) can get out free year of Fitbit Premium, which includes a health metrics dashboard guided programs and more. Plus you'll have access to coaching. Check healthsolutions.fitbit.com.

Eligibility will depend on a few things such as whether you already use Fitbi and where you are. A bonus for veterans who already use VA healthcare: You might qualify for a Fitbit Sense, which is the Fitbit health smartwatch.

If for some reason you can't get into the Fitbit program, you have othei options for exercise and working out Step one is to call the gyms closes to you and ask if they offer anything for veterans. CrossFit, Gold's Gym 24 Hour Fitness, OrangeTheory and numerous others offer discounts and special deals for veterans. Don't forge to try the non-chain locations. If you're eligible for Medicare, check into the Silver Sneakers program at local gyms many Medicare plans will pay for that. Near a base? 
